On January 7, 2011 Senator Carlson, Minnesota District 04 elect, made it public that he is in the process of authoring a bill that will lift the spearing ban on Cass Lake. This ban has been in place for 24 year and has protected the big pike and muskies of Cass Lake since its introduction. It is our job to voice our concerns on this matter and tell him that the ban should stay in place. The DNR is against the ban being lifted and we need to make sure that the removal does not happen. This bill passed the Senate and the House but the entire Fish and Game Bill of 2010 was vetoed by the Governor.
